EXECUTIVE SUMMARY

The Policy Development and Planning Bureau (PDPB) continuously monitors the status of implementation of Memorandum Circular (MC) No. 09, Series of 2019 or the "Guidelines for the Conduct of Research and Evaluation in the DSWD" otherwise known as the DSWD Research and Evaluation Policy. As part of the monitoring, a database of the Department's research and evaluation studies (i.e. planned, on-going, and completed) is maintained by PDPB. A report on the studies undertaken by the DSWD-Offices, Bureaus, Services, and Units (OBSUs), including external researches, capturing all approved proposals and/or final reports should be submitted to PDPB on an annual basis in order to ensure that the database is maintained and updated.

At the same time, with the issuance of the MC No. 10. Series, 2019 or the "Protocol for the Conduct of Research Studies in DSWD Offices, Centers and Institutions, Amending AO No. 19, Series of 2011 including Request of SWD Data/Information", otherwise known as the DSWD Research Protocol, the DSWD Central Office (CO) and Field Offices (FOs) should adhere to the aforementioned guidelines in providing assistance to researchers in conducting research and evaluation (R&E) studies in DSWD Offices, Centers, and Institutions.

Internal R&E studies undertaken by DSWD include studies initiated by the CO and FOs, whether conducted in-house, joint, or fully outsourced. On the other hand, external R&E studies facilitated refer to those proposed by external researchers and assisted by the CO and FOs. Presented below are the highlights of the inventory of R&E studies that were undertaken and facilitated by the Department in CY 2021:

RESEARCH AND EVALUATION STUDIES UNDERTAKEN BY DSWD **CENTRAL OFFICE**

- 1. The number of completed R&E studies undertaken by the DSWD Central Office-Offices, Bureaus, Services (CO-OBS) significantly dropped from six (6) in CY 2020 to four (4) in CY 2021.
- 2. In the CO-OBS, only the Policy Development and Planning Bureau (PDPB) and the Sustainable Livelihood Program-National Program Management Office (SLP-NPMO) have reported R&E studies undertaken and completed in CY 2021.
- 3. Most of the R&E studies undertaken by CO-OBS in 2021 were concentrated in the first two (2) Organizational Outcomes (OOs) of the Department, namely OO 1: Well-being of poor families improved, and OO 2: Rights of the vulnerable sectors promoted and protected.
- 4. The most common sector explored by the R&E studies undertaken by CO-OBS in CY 2021 was family and community at 40% to total.
- 5. Majority of R&E studies conducted by CO-OBS in CY 2021 were descriptive in nature.
- 6. Majority of the R&E studies undertaken by CO-OBs in CY 2021 were in-house.

RESEARCH AND EVALUATION STUDIES UNDERTAKEN BY DSWD FIELD **OFFICES**

- 1. A total of five (5) R&E studies were undertaken by DSWD Field Offices (FOs) in CY
- 2. As to sectoral distribution, majority of the facilitated R&E studies focused on the family and community corresponding to three (3) studies, children and youth and organizational with 1 each.

- 3. Majority of the FO-initiated R&E studies for CY 2021 were already completed, corresponding to 60% (3 out of 5) while there are 40% (2 out of 5) that are still ongoing and expected to be completed in CY 2022.
- 4. The most common sector explored by the DSWD FOs in CY 2021 was family and community.
- 5. Case study and impact assessment were accounted to have an equal number of R&E studies undertaken by the DSWD FOs in CY 2021.
- 6. All of the R&E studies undertaken by DSWD FOs in CY 2021 were in-house.

EXTERNAL RESEARCH AND EVALUATION STUDIES FACILITATED BY THE DSWD CENTRAL OFFICE AND FIELD OFFICES

- 1. From 75 reported facilitated external R&E studies in CY 2020, it significantly increased to 97 studies facilitated by DSWD in CY 2021.
- 2. The CO received the most number of research requests facilitated in CY 2021 corresponding to 17 or 17.52% of the total 97 requests facilitated by DSWD.
- 3. The most common sector explored by the external researches in CY 2021 was family and community corresponding to 38.14%.
- 4. OO1 and OO2 were accounted to have the most number of external researches requests facilitated with a total of 50 or 51.55% on OO2 and 32 or 32.99% for OO1 out of the total of 97 external research requests facilitated.

KEY RECOMMENDATIONS

- 1. Ensure to maximize the Online R&E portal for both CO-OBS and FOs to facilitate regular updating and monitoring of the facilitated researches.
- 2. Continue to advocate and popularize the research-related policies and PDPB to conduct technical assistance as may be necessary.
- 3. Strengthen the implementation and monitoring of the Client Satisfaction Measurement Survey to serve as the basis for evaluating the feedback of the researchers on the assistance provided.
- 4. Ensure proper dissemination of the findings of the facilitated studies to relevant stakeholders.
- 5. Ensure compliance of the external researchers to other policies of the Department. particularly on the ethical standards and child protection policy, among others.
- 6. Ensure that electronic and hard copies of either preliminary or final R&E report or manuscript were submitted by external researchers to the approving office of the Department.

BACKGROUND

The DSWD MC No. 09. s. 2019 or the "Guidelines for the conduct of research and evaluation" in the DSWD", otherwise known as the DSWD Research and Evaluation Policy, was issued

- 1. Institutionalize the formulation and monitoring of the DSWD Research and Evaluation Agenda; and
- 2. Provide standards and criteria in the conduct of researches and evaluation studies in the Department.

The policy covers all DSWD Offices, Bureaus, Services, and Units (OBSUs) in the Central and Field Offices tasked to conduct research and evaluation studies on the DSWD policies. programs, and projects. This shall include the development, management, and implementation of any research and evaluation study initiated by the Department, regardless of execution (i.e., in-house, joint, or outsourced).

Additionally, the policy applies to external stakeholders who partner with the Department in the conduct of researches or evaluations related to or involving the DSWD, such as local and international research institutions, the academe, independent researchers, other national government agencies, local government units, and DSWD attached agencies.

With the growing interest on research studies in the Department, DSWD MC No. 10, s.2019 or the "Protocol for the Conduct of Research Studies in DSWD Offices, Centers and Institutions, Amending AO No. 19, s.2011 including Request of SWD Data/Information", otherwise known as the DSWD Research Protocol, was also issued to:

- 1. Provide the standard protocols in conducting research studies in the Department and providing SWD data/statistics;
- 2. Define the role of the Central Office and Field Offices including external researchers in the processing of research request; and
- 3. Reduce the processing time for approval of research studies conducted by external researchers on DSWD Offices, Centers and Institutions.

This policy covers the following individuals/groups:

- 1. All DSWD Offices, Bureaus, Services, and Units in the Central and Field Offices, including Centers and Institutions tasked to provide data and assist external researchers in the conduct of research and studies.
- 2. External researchers such as students, academe, other government agencies including members of other branches of government, local and international organizations or research institutions, and other independent researchers who intend to conduct research studies related to or involving the Department.
- 3. Above-mentioned researchers seeking to acquire primary data from the Department including clients/beneficiaries currently at its Centers/Institutions, and on-going DSWD programs, projects, and services wherein their main subject of research study involves DSWD as an organization.
- 4. Academe, media, and general public who are not researchers but requesting current and secondary SWD data and statistics from the Department including clients/beneficiaries currently or served and programs, projects and services of the Department.
- 5. DSWD personnel conducting researches in DSWD Offices, Centers and Institutions, for the purpose of pursuing higher academic education.

With the issuances of the two (2) memorandum circulars, the PDPB is responsible to maintain an inventory of research and evaluation studies undertaken and managed by the DSWD, including external researches approved and facilitated by DSWD through the Central Office-OBSUs and Field Offices. This report presents a summary of the inventory for CY 2020, provides highlights of research and evaluation studies undertaken and facilitated, as well as recommendations to further promote the culture of research and evidence-based policy formulation in the Department.

STATUS OF CY 2020 CENTRAL OFFICE-INITIATED COMPLETED RESEARCH AND EVALUATION STUDIES

For CY 2020, a total of six (6) CO-initiated Research and Evaluation Studies were completed and have the following status:

Reassessing the Impact of the Pantawid Pamilyang Pilipino Program: Results of the Third Wave Impact Evaluation

- Updating the 4Ps framework for capacity building, gender mainstreaming, communications, and risk management.
- Development of program-based initiatives like the Bata Balik Eskwela (BBE) Initiative as well as Batang Malusog 0-5 years old FDS Module. The BBE Initiative won as Best M&E Initiative during the 5th DSWD Annual M&E Conference awarded in 13 September 2019.
- Preparation (and prioritization of resources) during Work and Financial Planning Workshops in 2019 and 2020.
- Providing responses to legislators' requests for clarifications, issues raised during budget hearings; presentation of presidential/administration accomplishments.
- Popularized, through various fora and conferences including NPMO M&E Forum, National Systems Conferences, Regional Program Management Conferences, Regional Program Coordinators' Meetings, Development Partners' Meetings, Missions, National/Regional Advisory Committee Meetings, Program Review and Evaluation Workshops.

Utilization of the Study

A comparative analysis between group and individual projects/enterprises was already included in the SLP's Research and Evaluation Agenda. The SLP under

- the PSMEU has already develop a concept note for this activity and will be included as one of the SLP In-House Studies to be conducted this CY 2022.
- Continuous exploring of partnership engagement with potential partner which can provide possible employment opportunities e.g., GRAB, SM Foundation Inc. (SMFI), DDT Konstract.
- The SLP-NPMO has already forged partnership with DPWH namely Trabahong Lansangan Project (TLP).
- Ongoing partnership proposal with DOLE and PESO-MAP on "Partnership for Gainful Formal Employment (PAGE) of SLP Participants.
- Conducted series of consultation meetings with Field Offices (through respective Training Officers) on potential and proactive measures and tools to respond to mentioned needs on the required and/or appropriate skills and capabilities of program participants.
- The study on the utilization of sorting tool may be undertaken by 2023 due to the limited budget and the PSMEU have two (2) evaluation studies to be prioritized this 2022.
- The PSMEU reiterated the importance of the data/information generated from the Organization Assessment Tool in the scheduled quarterly meeting with Regional and Provincial monitoring and Evaluation Officers conducted last April 2021.
- Provision of technical assistance to concerned staff of the SLP Regional Program Management Office may be undertaken by the Focal Persons of the Operations Division particularly on the processes of MC 22-2019 should the FOs will use the aforementioned guidelines for their CY 2022 targets.



RESEARCH AND EVALUATION STUDIES UNDERTAKEN BY **DSWD**


CENTRAL OFFICE-INITIATED STUDIES

The number of completed research and evaluation (R&E) studies undertaken by **DSWD** Central Office-Offices, the (CO-OBS) Bureaus. Services significantly dropped from six (6) in CY 2020 to four (4) in CY 2021. Only 4 R&E studies were completed by CO-OBS in 2021 based on the reports received. This can be attributed to underreporting of the completed studies by the DSWD CO-OBS and limitations in the movement of



personnel to conduct data gathering and other research related activities due to continuous restrictions in some areas brought about by the pandemic


It may be observed that since CY 2019, the reported completed R&E studies is constantly decreasing. The increase on the other hand in CY 2019 compared to CY 2017 to CY 2018, may be attributed to the significant strides of the Department to strengthen R&E efforts particularly establishing an integrated and comprehensive policy on R&E through the MC No. 09 series of 2019.




CO-OBS, In the only the Policy Development and Planning Bureau (PDPB) and the Sustainable Livelihood **Program-National Program Management** Office (SLP-NPMO) have undertaken R&E studies in CY 2021. Of the three (3) R&E studies conducted by PDPB, only two (2) or 66% was completed and the other one (1) is still ongoing. On the other hand, for the SLP-NPMO, two (2) of the R&E studies were both completed. Despite of the operational challenges during the height of the pandemic, the CO-OBS was able to undertake a total of four (4) R&E studies in

2021, most of which was completed within the year.

Most of the R&E studies undertaken by CO-OBS in 2021 were concentrated in **Organizational** the first two **(2)** Outcomes (OOs) of the Department, namely OO 1: Well-being of poor families improved, and OO 2: Rights of the vulnerable sectors promoted and protected. Three (3) of the R&E studies were focused on the OO1 wherein all were completed in CY 2021 while the other two (2) were concentrated on OO2 in which one (1) was already completed in CY 2021 and the other 1 is still ongoing.







The most common sector explored by the R&E studies undertaken by CO-OBS in CY 2021 was family and community. All of the R&E studies along family and community sector were already completed and the remaining ongoing study is along children and youth. There was no reported study undertaken for CY 2021 along

other sectors. For CY 2020, the most explored sector was also along family and community which was accounted at 40%.

Majority of R&E studies conducted by CO-OBS in CY 2021 were descriptive in **nature.** A total of three (3) studies were in descriptive form and there were two (20 studies on impact assessment. Based on DSWD R&E Policy. descriptive research examines situations in order to provide insights on the current situation/place/people/events and establish the current



norms, through scientific observation while the impact evaluation is the type of evaluation that seeks to answer the changes directly attributable to a program or the causal effect (impact) of a program on an outcome of interest.




Majority of the R&E studies undertaken by CO-OBs in CY 2021 were in-house. All of the in-house studies completed in CY 2021 while the remaining one (1) which is fully outsourced is still ongoing. Similar to the CY 2020 R&E studies undertaken, majority of the completed researches were in-house.

It is worthy to note that despite of the challenges encountered particularly in times of the pandemic, the Department continuously strive to ensure and intensify its functions along research and development, hence, the CO-OBS were able to undertake R&E studies for CY 2021

FIELD OFFICE-INITIATED STUDIES


A total of five (5) R&E studies were undertaken by DSWD Field Offices (FOs) in CY 2021. Majority of (3 out of 5) R&E studies initiated by the FOs were completed in CY 2021. Four (4) out of the 5 R&E studies were from FO Caraga, while the other one (1) was from FO II. No reports on FO-initiated researches were received from the other FOs. It is worthy to note that these FOs (II and Caraga) were the only FOs with FO-initiated R&E studies even in CY 2020.

Out of the five (5) FO-initiated R&E studies. two (2) were along Organizational Outcome 2 (002),another two (2) studies focused on OO1 and the one (1) was along OO5. The R&E studies about OO1 both focused on the Kapit-Bisig Laban sa Kahirapan-Comprehensive and Integrated Delivery (KALAHI-CIDSS) of Social Services which explored the line of fit of the envisioned development of its programs




for Indigenous Peoples (IPs) and enabling components for pandemic management. On the R&E studies about OO2, it looked into the impact of the programs and services in the centerbased facilities and readiness of the Assistance to Individuals in Crisis Situation (AICS) clients on digitalization. While, OO5 R&E study focused on the assessment of the effectiveness of Electronic Learning (E-Learning) Technical Assistance (TA) provision of the FO to the Local Government Units (LGUs).


In terms of the sectoral distribution, majority of the facilitated R&E studies focused on the family and community corresponding to three (3) studies, children and youth and organizational with one (1) each. In the CY 2020 report on the sectoral distribution of FO-initiated R&E studies, the same rank of distribution was observed. There were no reported R&E studies conducted on women/GAD, persons with disabilities and older persons, both for CY 2020 and CY 2021 based on the encoded information by the FOs. Similar with the CO-OBS initiated R&E studies, most of the explored sector was also along family and community and no studies conducted for the rest of the sector.



Majority of the FO-initiated R&E studies for CY 2021 were already completed, corresponding to 67% (3 out of 5) while there are 33% (2 out of 5) that are still ongoing and expected to be completed in CY 2022. Similar with the CY 2020 report, there were more completed R&E studies rather than the ongoing studies. It was observed that for CY 2021, the ongoing studies were those that were approved in the same year while the




completed studies corresponds to those studies that were approved in the previous year (CY 2020). The status of the R&E studies being facilitated, even with CO will depend on the time that the research proposal was submitted and approved as well as the duration of the study.




The most common sector explored by the DSWD FOs in CY 2021 was family and community. Majority (2 out of 3) R&E studies along family and community sector were already completed with 1 ongoing. **Studies** along children and youth and organizational were both ongoing. Similar sectors were explored as reflected in the CY 2020 report of the DSWD

FO-initiated R&E studies in which the family and community was accounted to be the most number of researches conducted.




Case study and impact assessment were accounted to have an equal number of R&E studies undertaken by the DSWD FOs in CY 2021. Descriptive study was also explored with 1 study. Case study as defined in the R&E policy refers to the in-depth investigation, which focuses on one or a few instances of a social phenomenon, e.g. a community, family, individual,

or historical period. Compared to CY 2020 DSWD FO-initiated researches, descriptive was accounted to have the most type of researches conducted.




studies All of the R&E undertaken by DSWD FOs in CY 2021 were in-house. Inhouse study was accounted to most have the explored approach even in CY 2020 studies undertaken by the FOs as well as with the CO-OBS. Though, it may be observed that majority of the studies were ongoing at the DSWD FOs.


EXTERNAL RESEARCHES AND EVALUATION STUDIES




It may be observed that from the CY 2017 reported facilitated external R&E studies, it was almost doubled in CY 2018 and constantly decreasing for the succeeding years. Prior to the pandemic, the significant decrease in the report may be attributed to underreporting while during the pandemic, strict imposition of quarantine protocols affected the conduct of studies due to the strict implementation of the quarantine protocols that restricted travels, face-to-face interventions and other regular activities. Nevertheless, the increase of at least twenty-two (22) in CY 2021 from CY 2020 may be attributed to the adoption of "new normal" wherein researchers can easily send their request via email and data gathering were administered online. Likewise, more researchers became interested to study the impact of the pandemic in the Philippines across all sectors.




The CO received the most number of research requests facilitated in CY 2021 corresponding to 17 or 17.52%. A total of 97 were facilitated in which majority (76 or 78.35%) were ongoing; 20 or 20.61% were completed and: 1 or 1.04% cancelled. Among all the FOs. FO NCR was accounted to have the most number of research requests facilitated. Meanwhile, FOs II, IX, X and XII have no reported external requests facilitated in CY 2021. Of the total of 97 facilitated external research requests.



The most common sector explored by the external researches in CY 2021 was family and community corresponding to 38.14%. Organizational was accounted to have 33 or 34.02%, followed by children and youth which is equivalent to 17 or 17.52%, next is the Women/GAD with 7 or 7.21%, persons with disability with 2 or 2.06% and older persons with 1.03%. All of the sectors were explored, similar with the CY 2020 report with the family and community as having the most number of sectoral focus and multisectoral with the least number




A total of ninety-seven (97) requests from external researchers were facilitated. Most of the external researches facilitated were conducted for masteral level of education with 42 or 43%, followed by bachelor level of education with 34 or 35%, 12 or 13% for research institutions and 9 or 9.23% for the doctoral level of education. Even in the previous years, most of the proponents requesting for researches were for masteral level of education.



OO1 and OO2 were accounted to have the most number of external research requests facilitated. A total of 50 or 51.55% on OO2, followed by 32 or 32.99% for OO1, 13 or 13.40% along foundational, 1 or 1.03 for the OO3. No external researchers explored on OO4 and OO5. In the CY 2020 reported external researches facilitated, both by the CO and FOs, OO2 was accounted to have the most facilitated research requests from external researchers.

Among all the topics under DSWD OO 1, the beneficiaries of 4Ps was the most common area of study. Researches in particular would like to explore on the knowledge, attitude, and practices of the program beneficiaries, as well as their compliance to the conditionalities of the program. In CY 2020, this area was also reported to have the most common area of study. On 4Ps alone, 8 or 28.57% were already completed by the external researches in CY 2021 while there were 19 or 67.86 ongoing and 1 or 3.57% cancelled. Most of the external researches were taking up their masteral's degree at 15 or 53.57%, bachelor's degree at 13 or 46.43%, doctoral degree at 1 or 3.57% and from corporates at 2 or 7.14%. The COVID-19 pandemic effect to the implementation as well as with the beneficiaries of 4Ps were explored by the external researchers.

On the other hand, researches on SLP implementation were all ongoing (3 out of 3) and the other one (1) on KALAHI-CIDSS implementation was completed in CY 2021. Most of the external researches (3 out of 4) were in their masteral's' degree and the other 1 is on doctoral degree.




Under OO2, studies on children and youth were the most explored focus of the study (36 out of 50 or 36%) and the least sectoral focus were on women and older persons. External researches in masteral's degree were among the highest number of research request facilitated for CY 2021.

- Ensure that electronic and hard copies of either preliminary or final R&E report or manuscript were submitted by external researchers to the approving office of the Department.
- Strengthen the implementation and monitoring of the Client Satisfaction Measurement Survey to serve as the basis for evaluating the feedback of the researchers on the assistance provided.
- Ensure compliance of the external researchers to research and evaluation policies and other issuances of the Department, particularly on the ethical standards and child protection policy, among others.

C. Other Needed Actions

- Conduct technical assistance to CO-OBS and FOs needing technical assistance in popularization of R&E related policies.
- Ensure to fully maximize the Online R&E portal for both CO-OBS and FOs to facilitate regular updating and monitoring of the facilitated researches.
- Ensure proper dissemination of the findings of the facilitated studies to relevant stakeholders for policy recommendations and program development and/or enhancement.
