DOCUMENTATION REPORT

Preliminaries

Ms. Shery Anne Calmada-Tabogoc officially started the session with the opening prayer and the acknowledgement of participants among the Field Offices (FOs), Local Social Welfare Development Offices (LSWDOs) and Central Office.

Opening Message

Asec. Niwane delivered her opening remarks with focus on the concerted efforts of all stakeholders particularly the FOs and LSWDOs in implementing the Social Welfare Development (SWD) Laws Online Monitoring.



She highlighted that in spite of the hurdles of the implementation both technically and operationally, the pilot test of the online monitoring tool was a success as evidenced by the participation of all Field Offices and the increase in the compliance of the Local Government Units (LGUs). She also encouraged the participants not to be intimidated by the

challenges, instead to transform them into opportunities in strengthening the performance of the department towards the fulfillment of its digitalization journey.

Objectives of the Activity

Ms. Airabelle Leyda gave a refresher of the previous activities leading to today's culminating activity. She further presented the objectives and programme flow.

The specific objectives of the activity were as follows:

- Present the analysis and assessment of the submitted and consolidated

LGU Compliance Monitoring Reports and Field Office Assessment Reports

- Discuss the issues encountered and recommendations to identify the areas of strength and development for the improvement of the system
- Recognize the valuable contributions of LSWDOs and SWD Laws Monitoring Team in the success of the pilot implementation

Secretariat's Journey

Mr. Louie Destacamento started his presentation with a brief introduction of the PDPB-Policy Development and External Affairs Division (PEAD) as the lead in the Policy Agenda which includes the SWD Laws Monitoring as a key component. He presented the journey of the SWD Laws Monitoring focusing on the key activities and initiatives in 2021 that contributed to the DSWD's thrusts and priorities as well as the international, regional and national commitments along SWD and poverty reduction:

- January 2021 - Social Protection Operational Framework and Human Development and Poverty Reduction Cluster (HDPRC) Roadmap 2019-2022;
- February 2021 - LSWDO Mapping;
- March 2021 - DSWD Policy Agenda 2022-2025 and Consultative Meetings with ALSWDOPI;
- April 2021 - Consultation Meetings on EO 138 or Devolution;
- May 2021 - Socioeconomic and Peacebuilding Framework 2020-2023;
- June 2021 - Orientation and Workshop on the Online SWD Laws Monitoring;
- July 2021 - National Policy Forum;
- August 2021 - Cascading Sessions on the Online SWD Laws Monitoring;
- September 2021 - Finalization of the Devolution Transition Plan;
- October 2021 - Cascading of the Proposed LSWDO Structure;
- November 2021 - Policy Study Sessions led by the PDPB;
- December 2021 - Assessment of the Online SWD Laws Monitoring

Objectives of the System

Ms. Leyda went over the objectives of the SWD Laws Online Monitoring as a review. She highlighted that the system aims to promote further the culture of monitoring especially in the LGUs along SWD as well as strengthen the role in Technical Assistance of the DSWD especially the Field Offices. The System also streamlines the existing SWD Monitoring at the local and regional level as part of the operationalization of DSWD's 2021 Thrusts of the Policy Agenda 2020-2025 and Operationalization of EO 138 focusing on the strengthening of M & E at the regional & local levels.

Analysis of the Report

Ms. Rosemarie Joy Lugtu presented the results of the pilot test with key findings as follows:

- Out of 16 Regions, Region CALABARZON had the most number of LGUs with online submission of LGU Compliance Monitoring Report followed by Regions VI, X, III, and V.
- FO NCR was the most compliant with 64.71% compliance rating, followed by FOs X, VI, CALABARZON & XI.
- Additional to the sector monitored this year is the IP Sector.
- 66.46% (1,104) of the target LGU offices and functionaries attended the cascading sessions.
- Most of the LGUs that participated in the pilot implementation were from 1st class (29%) LGUs while the least were from the 6th class LGUs (2.81%).
- Region CALABARZON has the most number of local policies issued with 205 local issuances followed by FOs X, III, VI, and XII.
- Most of the local policies issued were cross-sectoral in nature followed by family/community and children sectors.
- The top monitored SWD laws in terms of local issuances reported are for the following:
 - RA 7610 or Special Protection of Children Against Child Abuse, Exploitation, Discrimination Act
 - PD 603 or Child and Youth Welfare Code
 - RA 9262 or Violence Against Women and Children
 - RAs 10410 & 8980 or Early Years Act and Early Childhood Care and Development Act
 - RA 9710 or Magna Carta of Women
- While the following laws have the most Program/Project/Activity (PPAs) proposed:
 - PD 603
 - RA 9994
 - RA 10410 & RA 8980
 - RA 7160
 - RA 9710
 - RA 9262
 - RA 9442
 - RA 10754
 - RA 9344
 - RA 7277

- On the Issues and Gaps, the top issue cited was the lack of human resource complement of the LSWDOs to do its functions and roles. This was followed by the lack of funding, lack of local ordinances, COVID-19 restrictions and lack of physical resources.
- The lack of human resource complement comprises the integrity and adequacy of the case management, program design review and assessment, and attendance and lobbying to inter-office and inter-agency meetings
- On the other hand, the least cited issue was the lack of leadership support, program reach, program social preparation, program requirements and targeting.
- The recommendations for the various offices and units:

Sanggunian:

- Localization and implementation of ordinances in line with the national laws
- Enact/approve local policies supporting social welfare and development programs and services
- Appropriate resources and funding (human resource and PAPs)

LGUs:

- Review and support SWD laws, programs and services
- Allocate funding for M&E
- Appropriate funds for advocacies and IECs of SWD laws
- LSWDOs to establish partnership with other departments, organizations and LGUs
- Maximize alternative channels of delivery of programs and services, i.e., online, etc.

Field Offices:

- Conduct Technical Assistance and Resource Augmentation to LGUs on the emerging laws and its IRR, M&E, resource allocation and program implementation in the new normal
- Create an advocacies to lobby adoption of resolutions in the different programs across sectors
- Provide proposed organizational structure of LSWDO with attached policies mandating LGU to create the needed plantilla positions
- Provide capability buildings to LGUs
- Furnish copy of the assessment report to the Local Chief

Executive regarding functionality of LSWDO

- Intensify recommendations and understanding between national and local agencies on roles and obligations regarding accreditation process;
- Review accreditation tools/methods/process if viable or possible in the LGU or Barangay Level considering fund restrictions;
- Make a semestral follow up re: status of TARA findings and its corresponding recommendations to the LCE.

Inter-agencies:

- Lobby support in the issuance of local policies
- Provide technical assistance on the emerging SWD laws and its IRR
- Provision of situational analysis
- Initiate creation of memorandum circulars, agreement, resolutions, among others
- Monitor compliance of LGUs to regional commitments

The following observations was made in the review of the recommendations made:

- Some recommendations are not aligned with the mandate of the concerned office/agency;
- Almost all recommendations are focused on administrative and logistics concerns not on program design/effectiveness;
- Recommendations are not supported by sectoral statistics;
- Recommendations are not anchored on the provincial and/or regional targets and variances; and
- No comprehensive recommendations for LGU functionaries (LPDC, Local Administrator, PESO, among others), FO functionaries (TARA focal, SWD team, Combased focal), and Regional Inter-agencies

Analysis and Assessment of the Reporting

Mr. Destacamento presented the evaluation of the system with the following highlights:

- Only 89 LGUs participated in the assessment survey. This is 25% of the total 534 LGUs who participated in the online SWD Laws Monitoring;
- 72.3% of the respondents said that the system using the KOBO tool was

easy to enter, operate, use and understand;

- However, 42.6% said that the system consumed their internet usage while 40.6% said that the system experienced frequent lags;
- On the LGU Compliance Monitoring Form, 78.40% of the respondents said that the requested data were relevant and 63.6% said that data generated from the report can be used as reference materials to other plans or reports;
- On the Field Office Assessment Form, 84.6% said that the Data generated from the report can be used as reference materials to other plans or reports

To contextualize these assessments, Mr. Destacamento provided the various projections and situational analysis of the Philippine social and poverty landscape based on different literatures. He also gave a refresher on the objectives of assessment and reporting in the purview of M&E.

The key recommendations for the enhancement of the system are as follows:

Form:

- Additional box for the monitoring and tagging of PAPs relative to CDP commitments
- Exclusive recommendation box for PSWDOs
- Additional box for the monitoring of International SWD Laws
- Clustered inventories of (implementation vs design) issues/gaps
- Availability/access to the submitted report
- Sectoral layout instead of thematic layout
- Sharing of prototype Assessment Report

Content:

- Conduct the monitoring and assessment of SWD laws in collaboration with LGU functionaries.
- Invest in a strategic communication plan to get the buy-in of CSOs for check and balance but focus on internal communication strategies to win the support of local administrator, budget officer, LPDC, Sanggunian and the LCE.
- Focus on the implementability of recommendations. Consider categorizing into short term, medium term and long term.
- Assessment and recommendations should be supported by sectoral statistics, and should be anchored on the provincial and/or regional

- targets and variances
- Reactivate the TARA function of PSWDOs




